Clients Represented Before The Texas Board of Pardons and Paroles

I have been representing clients before the Texas Board of Pardons and Paroles since 2001. This chart documents a selection of those representations beginning in 2020, when I began keeping a formal record of outcomes. It spans six years, hundreds of presentations, and some of the most serious and complex cases that come before the Board. I have represented clients across every major Texas panel, including Palestine, Angleton, Huntsville, Amarillo, Austin, Gatesville, and San Antonio. The cases reflected here include some of the most serious offenses in the Texas Penal Code: capital murder, aggravated sexual assault of a child, trafficking, and murder, among others.

These are not easy cases. They require preparation, strategy, and a deep understanding of how the Board evaluates risk and rehabilitation. I deliberately limit my caseload so that every client receives my personal attention, not a paralegal, not a case manager, not an assembly line. This record reflects that work.

Every case is different. The facts, criminal history, institutional record, and circumstances that each individual brings to the Board are unique. A favorable outcome in a case listed here is not a guarantee or prediction of the outcome in yours. No attorney can promise a result before the Parole Board, and you should be cautious of anyone who does.
